ADVANCED CARDIAC LIFE SUPPORT 1-Day Renewal Course

FEE: \$150

Designed for the experienced provider, this is a fast-paced course covering sudden cardiac arrest and other cardiac emergencies, utilizing case-based scenarios. All participants must complete an ACLS online Precourse Self-Assessment, score a 70% or above, print the results from the same computer, and bring the printout to class. Failure to do so will require rescheduling the face-to-face class on a different day.

ASLS Blended is a new innovative, 2-part web and skills curriculum developed by the Gordon Center with the American Heart Association. Built upon the Gordon Center's instructor-led curriculum in use since 1998, the content is up-to-date and tailored to the individual learner through adapative learning, with interactive graphics, animations and simulation. Registrants are emailed instructions on accessing their chosen online course track, which must be completed prior to the date of their scheduled, in-person skills evaluation. They demonstrate the required skills using the stroke scale of their choice.

REGISTRATION:

All live classes take place at the Gordon Center for Simulation and Innovation in Medical Education, 1120 N.W. 14 St., first floor, from 8:00 a.m. until 5:00 p.m., unless indicated otherwise. Our Florida Board of Nursing and EMS Provider Number is FBN 50-329. Our CAPCE provider number is UMIA0005. The Gordon Center is also accredited as a provider of continuing nursing education by the American Nurses Credentialing Center (ANCC) Commission on Accreditation.

Classes are subject to cancellation or rescheduling if minimum registration is not achieved.

Fees: Course materials are included, unless otherwise noted. With the exception of the web courses for Florida responders, prepayment of tuition or prior arrangement for departmental billing is required. MasterCard, Visa, American Express and Discover Card are accepted, as are checks; no cash. AHA course materials may be picked up in advance; shipping charges are additional.

Refunds: Refunds or credit for future classes will only be issued with notification of withdrawal at least two days prior to the date of class. Requests for refund must be in writing, include the reason for withdrawal and be received no later than 30 days following withdrawal. Tuition will be refunded minus 15% for administrative costs plus the cost of any course materials provided. Should a class be cancelled or rescheduled, the course fee is refundable in full upon request.
